Legislation of GI in Bosnia and Herzegovina

- The legal framework remains to be improved and harmonised with relevant EU acquis, in particular concerning wine and spirit drinks, and a clear distribution of competences needs to be ensured (EC 2022 Country Report on Bosnia and Herzegovina - Quality Policy).
- The protection of food with geographical indications is regulated by the Regulations on quality systems for food products (Official Gazette of BiH, No 90/18) and the Regulations on the appearance and manner of use of the protected designation of origin, geographical indication and traditional speciality guaranteed designation of food products (Official Gazette of BiH, No 82/19). The competent authority is the Food Safety Agency of BiH.
- Law on the organisation of the wine market in BiH (Official Gazette of BiH, No 63/23). It is necessary to adopt by-laws on the protection of wines with geographical indication. The competent body would be the Ministry of Foreign Trade and Economic Relations of Bosnia and Herzegovina.
- It is necessary to adopt a new Code on the definition, description, presentation, labelling and protection of geographical indications of spirit drinks in line with Regulation (EU) 2019/787. The competent body for the protection of geographical indications of strong alcoholic beverages is the Food Safety Agency of BiH.

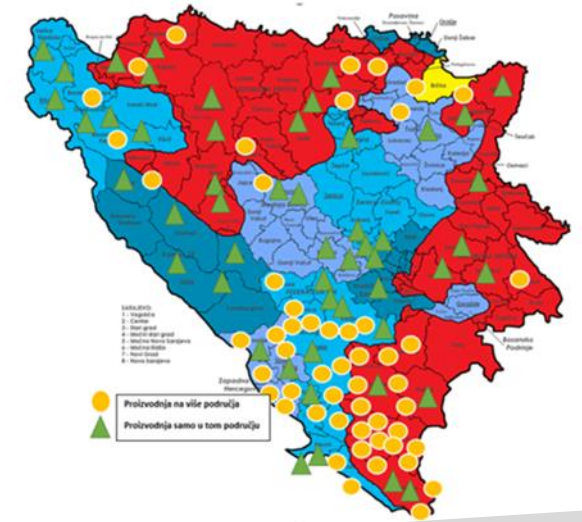

Experiences of BiH

- For a country in the EU's neighbourhood, geographical indications are a very important tool for rural development and have a direct impact on sustainability
- In BiH, we started with the story of the geographical indication in 2010, and legislatively aligned with the EU at the end of 2018.
- Successful implementation of geographical indications required a collective effort and the support of international organisations (FAO, UNDP, EU, USAID...) was extremely important for the inclusion of all actors in the value chain.
- The inclusion of these organisations opened a new chapter in BiH and the registration of geographical indications and TSG food was raised to a higher level.
- There was a need for support during the formation of the Group and the preparation of the product specification in the process of preparing the geographical indication.
- Support to the members of the Producers and Processors Group and strengthening the capacities of the Protected Products Group is of paramount importance and is still not sufficiently recognised by local policies.

Experiences of BiH

The manufactures of all products with potential geographical indications are simply not yet ready to start the process of protection.

Each product is different and has specific obstacles to overcome

For those products where the producers already have some form of cooperation and some experience, the preparation of the application dossier takes a minimum of 12 months. For some others even more.

Quality documentation requires transparency from the outset and the involvement of all stakeholders, especially scientific institutions

Support for the transition of protected geographical indication products at national level to an EU protection process

The need to involve the competent national authority for geographical indication and TSG-s from the outset in the product registration process

Pre-and post-marketing controls

- A legal framework has been set up to take measures for the official control of protected products and the fight against food fraud.
- The cooperation of the National Geographical Indications Authority with the authorised certification bodies carrying out pre-marketing controls is of great importance for the sustainability of the concept of geographical indications in a country.
- Inspectors in the official control of geographical indication products on the market shall undergo additional training.
- It requires the development of a marketing strategy for geographically marked products.
- The need to strengthen capacity and take the necessary steps to include local products in the national and EU registers of geographical indications, as well as to control and prove counterfeiting and fraud.
